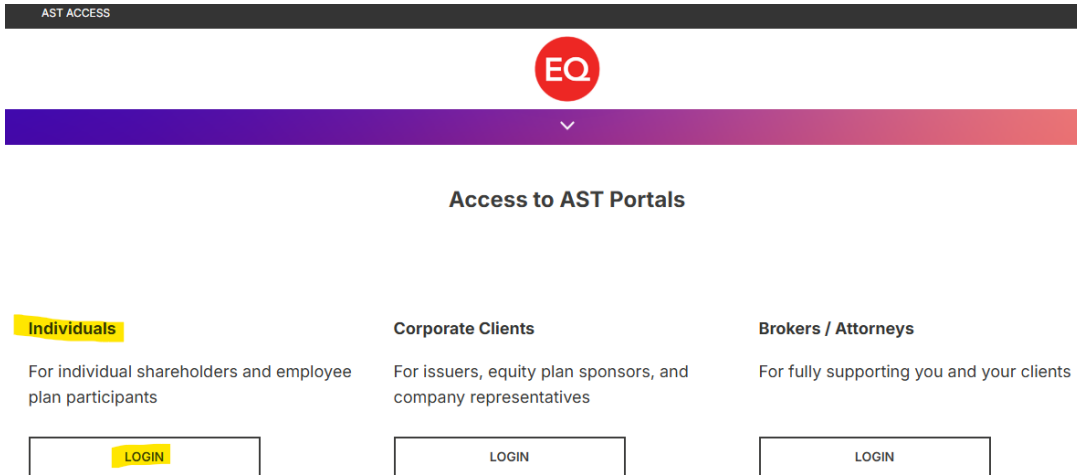
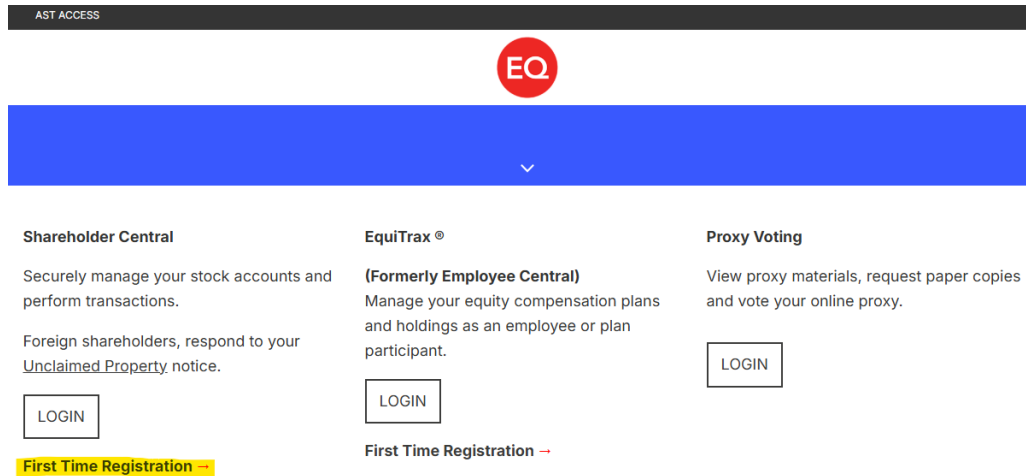


# AST/Equiniti LOGON Instructions

1. Go to: <https://equiniti.com/us/ast-access/>
2. Click on the **login** button under INDIVIDUALS on the far left of the page:



3. On the next screen, under Shareholder Central, there is a link labeled: **FIRST TIME HERE? REGISTER.** Click on this text; (circled in yellow below). **DO NOT click the LOGIN button.**



4. On the next screen, in the field labeled **Account Number**, enter your 10-digit account number. This is a 10-digit number equal to **1 + 000000** (6 zeros) + **your 3-digit current account number (CU number)**.
